

REMOTE ONLINE NOTARY APPLICATION CHECKLIST

As of January 1, 2020, Florida is taking the next step in closing convenience by allowing Remote Online Notarization ("RON") of documents. RON Notaries must be approved by the State of Florida Division of Corporations. This document will guide you through your RON application, indicating which documents are needed and what information you need to provide to the State to become approved.

To apply to be a Remote Online Notary ("RON") in the State of Florida, you must:	
	Be a current Notary Public, Civil-Law Notary or Commissioner of Deeds appointed in the State of Florida
	Take a two-hour statutory required course and pass the quiz upon completion
	» WFG's preferred course is provided by the Florida Land Title Association and the Real Property, Probate & Trust Law Section of the Florida Bar
	» The course is online only at this time and costs \$20
	Contract with a third-party RON Service Provider
	» As of February 1, 2020, WFG National Title Insurance Co. has authorized <u>Notarize.com</u> and <u>NotaryCam</u> as RON Service Providers
	» A RON Service Provider will assist you in online record keeping, knowledge based authentication to prove your signatory's identification, and attaching your electronic notarial certificate to the notarized document
	Obtain a Surety Bond and Errors and Omissions insurance, each in the amount of \$25,000
	» If your bonding agency is unable to issue the Surety Bond and/or the Errors and Omissions Insurance in the amount of \$25,000, please contact Underwriting for further information
	Review the applicable legislation and statutes relating to RON
	» <u>Chapter 2019-71, Laws of Florida</u>
	» <u>1N-7001, Florida Administrative Code</u>
	» <u>Notaries Public - Chapter 117, Florida Statutes</u>
	Understand that your RON commission will expire with your Notary Public Commission

Documentation checklist for application submission:

	Application for Remote Online Notary
	» This application needs to be notarized prior to mailing
	Certificate received after completion of the educational course and quiz
	Proof of your \$25,000 Surety Bond
	Proof of your \$25,000 Errors and Omissions insurance
	Copy of your commission or appointment as a Notary Public, Civil-Law Notary, or Commissioner of Deeds
X	A copy of the commission detail from the <u>Florida Notary Lookup website</u> is NOT sufficient for this purpose - you will need the actual certificate sent to you by your bonding agent
	\$10 check payable to Florida Department of State

Once you have completed the above steps, mail your application package to:

There is no online submission option as of February 1, 2020. You should receive your commission within approximately two weeks from date of submission.
